# Comments on the Spring 1975 Meeting

The Spring Meeting of 1975 was held at the Baltimore Hilton in downtown Baltimore on April 25 and 26. Seventy-eight persons registered as conferees. Eight exhibitors displayed their products.

The morning session, "A Symposium on the Responsibility and Posture of the Expert in the Courtroom" was very well received. In fact, the Open Panel Forum almost ran into the lunch hour.

The afternoon session of the 25th was a potpourri of the forensic scientist skill and versatility. The social hour was a decided success and the banquet came off in great style. The Saturday morning session on Drugs was very well done. The

caliber of the papers was outstanding. The attendance was much less than Friday's but a respectable number was in attendance. Finally the tour of the Baltimore Police Laboratory even though a minimum number attended was top drawer in quality.

As an interested MAAFS member I approached this meeting with certain objectives in mind. First, I wanted to hear what was new in the forensic community. Second, I wanted to associate organizational names with real people. Third, I was anxious to hear the remarks of the invited speakers on the posture of the expert in the courtroom. Fourth and last I wanted to see if the wide variety of people, organizations, geographical representations could function as a viable entity.

I believe that each of my objectives was met in a most admirable manner. I was impressed with the depth and meaningful papers that were read at the various sessions. As our speaker Paul R. Kramer, Dep. U. S. Attorney, said "You sure have some pretty girls in your membership". The panel on the posture of the expert in the courtroom was excellent. They provoked thought in each of us. We all have a responsibility and I believe that the session refocused our efforts to be the best possible witness when we get into that courtroom. Last and certainly not least is the remarkable stance our society has. The spring meeting was not even over and the Fall and Spring 1976 meetings were already being planned. This is surely a great sign that we have a real live organization.

- (5) To have Meetings start with Luncheon, followed by the Business Meeting, on Friday, followed by the Program Not Carried
- (6) The Program Chairman to have complete autonomy as to the choice of setting the times Carried

A Vote of Thanks was given to Drs. Cantu and Lundy for the Cards and Certificates.

Dr. Cantu was asked to investigate the requirements for reporting Bank Accounts to the IRS, and to report to the Chairman.

If extra money is available, it was suggested that we have an Award for an outstanding member, possibly on an annual basis.

Since the Letterhead has no return address, it was recommended that the Executive type in their own address. It would then not be necessary to get new stationary every time the Executive changes.


