MAAFS 18th Meeting — Virginia Beach

Minutes

The meeting was called to order by President Gerald Richards at 5:01 PM, September 24, 1981, at the Virginia Beach Holiday Inn.

President Richards thanked everyone for attending, and remarked that he thought this was one of the biggest and most well attended meeting MAAFS has had outside of the DC area. He noted there were 98 attendees at the meeting. He mentioned that you have to attend the business meeting to be credited with attendance

An attendance sheet was passed around for signatures. It was noted that the sheet must be signed to be credited with attendance.

President Richards appointed Edward Franzosa as Parliamentarian for the meeting.

The results of the election were announced by the President. President-Elect is Richard Tontarski and Member-at-Large is Carrie Parker.

President Richards turned over the office of President to Delbert Agee who assumed the office. His first order of business was to note that the minutes of the last meeting (Spring 1981 – Charlottesville, Virginia) were published in the last issue of the Newsletter (Volume 9, Number 3, September 1981.) It was moved and seconded that the minutes be accepted as published. The President called for the vote and the motion carried.

President Agee called for the Treasurer's Report which was read by Michael McGee. It was moved and seconded that the report be accepted as read. The President called for the vote and the motion carried. President Agee next called for the proposed budget from the Budget Committee. The proposed budget was read by Michael McGee. It was moved and seconded that the budget be accepted as read. The vote was called and the motion carried. There was discussion as to whether the present Certificate of Deposit should be reinvested in a different type of account which would give more return for our money. It was

moved and seconded that the Executive Committee examine the question and take appropriate action. The President called for the vote and the motion carried.

AWARDS COMMITTEE: Rose Lanzetta requested that members fill out the form in the Newsletter for the Scientist of the Year Award. A Certificate of Appreciation was awarded to Gerald Richards for his work as P.esident during the term 1980-1981. A Certificate of Appreciation was awarded to James Mudd for acting as Chairman at the Spring 1981 Meeting. Also certificates were awarded to Bruce Given, Richard Gervasoni and Richard Tontarski for their work during the Spring 1981 Meeting.

MEMBERSHIP COMMITTEE: Antonio Cantu announced the new members to the Association: Chris Ann Houghton, Anthony Burke, Howard Schlesinger, M. Zamir Haq, Stephen Cain, Joseph Guth, R. Johnson, Roger Covington, Carol Schreiber, K. G. Rao and Mark Fredenburg. The President requested a report from Joseph Koles. He noted the rules for promotion of a charter or regular member to the emeritus status. These include that the person must have 25 years of service in the field of forensic science and/or be at least 65 years old and have had 5 years membership in the Association. To be promoted a person must be proposed to the Membership Committee. [There is a form in each Newsletter for this purpose. - Editor.] Two names were proposed for the promotion: Bell Herndon and Tom Everhart. The motion to promote these two people was made and seconded. The motion carried.

DIRECTORY COMMITTEE: Tony Cantu was asked to make a report on the progress of the directory. He noted that the directory was in its final stages of completion and would be ready for publication soon.

TEE-SHIRT COMMITTEE: Ed Franzosa report-

ed that no really good slogan had been proposed and that further research would take place at the hospitality suite that night.

President Agee asked for a report from Mike McGee on the upcoming Fall 1982 Meeting. He noted that the meeting would be a joint meeting between MAAFS and the Society of Forensic Toxicologists. It will be held at the Westpark Hotel, Rosslyn, Virginia, on October 13-15, 1982. Further details will be published in the Newsletter. Hopefully there will be workshops directly before the Meeting.

OLD BUSINESS:

Notification was made that if a member fails to attend at least one in six meetings he will be dropped from membership. This rule can be waived if an acceptable letter explaining why the person could not attend any meetings is sent to the Executive Committee via the Secretary-Treasurer. See the list in the box on page two for those whose membership is in jeopardy.

Ed Franzosa stated that if a person lives outside the area he is a corresponding member. Our area includes Maryland, Pennsylvania, Virginia, West Virginia, Delaware and the District of Columbia. A corresponding member is not required to attend meetings.

Late 1981 membership cards were issued. The recipients were: Dennis Reutter, Gene Reichenbecker, Cecil Yates, Gene Rieder and Robert Strader.

President Ages asked whether the members liked having the meetings held on the present Thursday/Friday format rather than the old Friday/Saturday format. The majority of the members prefered the present format.

It was noted that the Executive Committee is now meeting twice a year separately from the semiannual meetings. Formerly the Executive Committee only met at the semiannual meetings.

NEW BUSINESS:

Ed Franzosa asked if the members felt it would be advantageous to publish our abstracts in the Newsletter after our meetings. A suggestion was made to list the title and author of the paper only, thus minimizing costs. Members could then write the author directly requesting reprints. It was decided that Ed would include the title and author of papers presented at MAAFS as well as the other regions in the Newsletter for one year. The results of this year-long experiment will be discussed at the Fall 1982 Meeting. Ed Franzosa brought up the fact that there is not a journal of/for/by the criminalist. The journal would have to be supported by at least 5 of the 7 regional forensic associations. The regions would each contribute \$1000 initially. All members of each contributing region would automatically receive the new journal. If at the end of one year the journal is not successful it will fold and any remaining funds will be distributed equally among the contributing regional groups. It was brought up that the FBI Crime Lab Digest was designed to fill this same void. President Agee suggested that Ed Franzosa talk with Tom Hughes, of the FBI, concerning the Digest and report to the Executive Committee. Ed mentioned that he was rewriting the journal proposal and would report the outcome to the membership.

The President announced that Dr. David Crown has resigned from MAAFS.

Tony Cantu discussed the possibility that MAAFS representatives speak on forensic topics to judge and attorney associations upon request. Volunteers would be needed. All interested members were requested to get in touch with Rick Tontarski. The feasibility would be discussed at the next meeting.

It was moved and seconded that the meeting be adjourned. The motion carried and the meeting was adjourned at 6:17 PM.

Members in Trouble!

According to the MAAFS By-Laws, each charter and regular member is supposed to attend at least one of each six business meetings (i.e., one every 3 years.) This rule was included to insure that the MAAFS business meetings would have sufficent members present to meet our quorum requirements, not to harass the members. If a member does not attend one in six business meetings, then the association "will automatically terminate the membership of said member."

If members have valid reasons for not being able to attend one of six business meetings, then they may write a letter to the MAAFS Executive Committee explaining why they should be excused from this requirement UNTIL the next meeting. After being excused from the attendance requirement, that does NOT mean that a member has another three years to meet the By-Laws' requirement, rather his membership would be in jeopardy at the next meeting again as he would still have not attended a single meeting in the previous five.

The following MAAFS members have not attended any business meetings in 1979, 1980 and 1981. To keep their membership in MAAFS, each must write a letter to the Secretary-Treasurer, Larry Stewart (at BATF National Lab, 1401 Research Boulevard, Rockville, MD 20850), requesting that they be excused from the attendance requirement until the Spring 1982 meeting. The deadline for submitting this letter will be February 1, 1982.


